# LEGAL REQUIREMENTS FOR WEDDINGS IN JAMAICA (PRINCESS SENSES THE MANGROVE AND PRINCESS GRAND JAMAICA)

## **LEGAL CEREMONY - REQUIRED DOCUMENTATION**

- Notarised copies of the birth certificates of both partners (long version for Canadian citizens)
- Notarised copies of national identity documents (passport or driving licence)
- Notarised final divorce notice (if applicable)
- Notarised death certificate (in the case of widowhood)
- Notarised document of change of name or adoption documents, if applicable
- Notarised authorisation from parents if either of the parties is under 18 years of age
- Official English translation of all documents if they are in another language
- Completed Wedding Agreement form, with valid details for the date of the ceremony

## RENEWAL OF VOWS / SYMBOLIC CEREMONY - REQUIRED DOCUMENTATION

- Notarised copy of marriage certificate
- Notarised copies of national identity document (passport or driving licence)
- Completed marriage agreement form
- Important: Symbolic ceremonies are not legally binding in Jamaica.

#### **DOCUMENTATION SUBMISSION**

- All documents (as applicable) must be sent at least 2 months prior to the desired wedding date
- Documents may be scanned and sent by email
- Princess is not responsible for documents not received through postal or courier services
- The hotel cannot retrieve documents sent to addresses other than the resort and will not return original documents
- Once the forms have been signed, the Minister will forward the documentation to the Civil Registry. The issuance of official marriage certificates takes between 6 and 8 weeks

#### RESIDENCY REQUIREMENT

- Couples must arrive in Jamaica at least 48 hours before the ceremony
- This is necessary in order to comply with legal requirements and ensure sufficient time for final preparations
- Ceremonies must be booked at least 6 months in advance, although bookings made less than 6 months in advance will be taken into consideration, depending on availability

#### MARRIAGE CERTIFICATE AND INTERNATIONAL VALIDITY

- A copy of the Marriage Register is presented on the day of the wedding
- Two certified copies of the Official Certificate are sent to the couple between 6 and 8 weeks after the ceremony
- Marriages performed in Jamaica are legally recognised in the United States, Canada, the United Kingdom and most countries worldwide
- It is recommended that validity requirements in the couple's country of residence be verified in order to confirm whether any additional paperwork is required

#### **AUTHENTICATION AND LEGALISATION OF CERTIFICATES (OUTSIDE JAMAICA)**

Residents of countries where English is not the official language must complete additional procedures. These involve a fee that will be notified by the Wedding Specialist. The process includes:

- Legalisation at the Ministry of Foreign Affairs in Jamaica
- Authentication by the relevant embassy or consulate in Jamaica
- Mandatory procedure to ensure the validity of the certificate in certain countries
- Countries requiring additional authentication and legalisation: Germany, Switzerland, Italy, Poland, Netherlands, Ukraine, Austria, Sweden, Norway, Malta, Czech Republic, Iceland, Lithuania, Finland, Croatia, Romania, Hungary, Denmark, Luxembourg, Morocco
